CAUTION

ENVIRONMENTAL HAZARDS:

This product is toxic to non-target plants and aquatic invertebrates. Do not apply directly to water, to areas where surface water is present or to intertidal areas below the mean high water mark. Drift or runoff may be hazardous to non-target plants and aquatic organisms in neighboring areas. Do not apply where runoff is likely to occur. Do not apply when weather conditions favor drift from treated areas. Do not contaminate water when disposing of equipment washwaters.

GENERAL RESTRICTIONS AND LIMITATIONS

- Do not apply to frozen or snow covered soil.
- Mechanical incorporation into the soil will reduce residual weed control.
- **Spray equipment used to apply *Chateau* SW should not be used to apply other materials to any crop foliage, unless the proper cleanout procedures are followed. See "SPRAYER CLEANUP" on the container label for more information.**

DIRECTIONS FOR USE IN POTATO

GENERAL RESTRICTIONS AND LIMITATIONS

- Do not apply more than 1.5 oz. of *Chateau* SW per acre during a single application.
- Do not apply more than 1.5 oz. of *Chateau* SW per acre during a single growing season.

TIMING TO POTATOES

Chateau SW may be applied to potatoes after hilling for the preemergence suppression of the weeds listed in Table A, Weeds Suppressed by Residual Activity of *Chateau* SW at 1.5 oz./A. *Chateau* SW should be tank mixed with other labeled herbicides for broad spectrum weed control. A minimum of 2 inches of soil must cover the vegetative portion of the potato plant at the time of *Chateau* SW application. Application to potatoes with less than 2 inches of soil covering the vegetative portion of the potato may result in crop injury.

TIMING TO WEEDS

Preemergence – Soil Covered Potatoes, Preemergence To Weeds

Apply *Chateau* SW to soil covered potatoes for the preemergence suppression of the weeds listed in Table A, Weeds Suppressed by Residual Activity of *Chateau* SW at 1.5 oz./A.

Read tank mix product label for rates and weeds controlled. Always read and follow label directions for all tank mix products before using. The most restrictive labeling of any tank mix product must be followed.
