## CHATEAU® HERBICIDE SW USE ON GARBANZO (DRY BEAN) FOR WEED SUPPRESSION

### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**READ ENTIRE LABEL. USE STRICTLY IN ACCORDANCE WITH PRECAUTIONARY STATEMENTS AND DIRECTIONS, AND WITH APPLICABLE STATE AND FEDERAL REGULATIONS.**

### RESTRICTIONS AND LIMITATIONS

- Do not apply more than 1.5 oz of *Chateau SW* per acre during a single application.
- Do not apply more than 1.5 oz of *Chateau SW* per acre during a single growing season.

**Many weather related factors, including high wind, splashing or heavy rains or cool conditions at or near crop emergence, may result in garbanzo bean injury in fields treated with *Chateau SW*. On occasion this has resulted in a delay in maturity. User should assume these risks before using *Chateau SW*.**

### TIMING TO GARBANZO (DRY BEAN)

*Chateau SW* may be applied to garbanzo beans within 2 days after planting for the preemergence suppression of the weeds listed in Table 1, Weeds Suppressed by Residual Activity of *Chateau SW* at 1.5 oz/A. *Chateau SW* should be tank mixed with other labeled herbicides for broad spectrum weed control.

### TIMING TO WEEDS

*Chateau SW* may be applied to garbanzo beans prior to planting or preemergence (after planting). Preemergence application of *Chateau SW* must be made within 2 days after planting and prior to garbanzo bean emergence. Application after the garbanzo beans have begun to crack, or are emerged, will result in severe crop injury. Application should not be made when garbanzo beans have begun to crack.

Preplant incorporation (PPI) applications may result in reduced weed control.

## ADDITIONAL RESIDUAL GRASS CONTROL

*Chateau* SW can be tank mixed with pendimethalin for additional grass control.

Read tank mix product label for rates and weeds controlled. Always read and follow label directions for all tank mix products before using. The most restrictive labeling of any tank mix product must be followed. *Chateau* SW, when applied according to label use directions, will suppress the weeds listed in Table 1, Weeds Suppressed by Residual Activity of *Chateau* SW at 1.5 oz/A. This label makes no claims concerning other weed species.
