DIRECTIONS FOR USE

This recommendation is made as permitted under FIFRA Section 2(ee) and has not been submitted to or approved by the EPA.

This 2(ee) bulletin contains directions for use, which do not appear on the package label of *Resource* Herbicide or glyphosate.

USE RESOURCE HERBICIDE AT 2 TO 4 FL OZ/A PLUS GLYPHOSATE AT 1.0 LB AI/A TO CONTROL MORNINGGLORY SPP. IN ROUNDUP READY SOYBEANS.

Adjuvant: *Resource* plus glyphosate tank mixes must be applied with a nonionic surfactant* at 0.25% v/v (one qt/100 gallon spray solution).

*nonionic surfactant must contain at least 90% active ingredient.

Use Restrictions for the *Resource* Plus Glyphosate Tank Mix

1. Always read and follow all label directions when using any pesticide alone or in tank mix combinations. The most restrictive labeling applies when using a tank mix.
2. Read and observe all precautions, restrictions and conditions on the glyphosate label.
3. The *Resource* plus glyphosate tank mix will not control bigroot morningglory or any other perennial morningglory.
4. Do not apply the *Resource* plus glyphosate tank mix to Roundup Ready soybeans within 60 days of harvest.
5. Do not apply more than a total of 16 fl oz/A of *Resource* to Roundup Ready soybeans during a single growing season.
6. Do not apply the *Resource* plus glyphosate tank mix if rain is expected within 1 hour of application otherwise, unsatisfactory weed control may result.
7. Do not apply during low level inversion conditions, when winds are gusty, or any other condition which favors drift. Drift to sensitive vegetation may cause serious injury - appropriate buffer zones must be maintained.
8. Carefully select proper nozzle and spray pressure to avoid spraying a fine mist, twinjet nozzles are NOT recommended.
9. Apply the *Resource* plus glyphosate tank mix to actively growing weeds. Applications made when the crop or weeds are under stress from moisture, cold, heat, high humidity, disease, insects or prior herbicide applications may result in excessive crop response and/or reduced weed control.
10. A sequential application of the *Resource* plus glyphosate tank mix may be required when additional weed flushes germinate after the initial *Resource* plus glyphosate tank mix application.
11. Do not graze animals on green forage or stubble. Do not utilize hay or straw for animal feed or bedding.

Follow all applicable directions, restrictions and precautions on the EPA-registered labels. This labeling must be in the possession of the user at the time of pesticide application.

It is a violation of Federal law to use these products in a manner inconsistent with its labeling.
