Phytotoxicity has been observed on the following plants: <i>Salvia</i> ( <i>Salvia</i> spp.), Ghost Plant ( <i>Graptopetalum paraguayense</i> ), Boston Fern ( <i>Nephrolepis exaltata</i> ), Schefflera ( <i>Schefflera</i> spp.), Gardenia ( <i>Gardenia</i> spp.) and Coral Bells ( <i>Heuchera sanguinea</i> ). It is therefore recommended that <i>Distance</i> Insect Growth Regulator not be used on these plants. DO NOT APPLY TO POINSETTIA AFTER BRACT FORMATION.
