**ENVIRONMENTAL HAZARDS:** This pesticide is toxic to freshwater and marine/estuarine aquatic invertebrates, including oysters and shrimp. Do not apply directly to water or to areas where surface water is present or to intertidal areas below the mean high water mark. Do not apply when weather conditions favor drift from treated areas. Drift and runoff from treated areas may be hazardous to aquatic organisms in water adjacent to treated areas. Do not contaminate water when disposing of equipment washwaters or rinsate.

The active ingredient in this product is extremely toxic to freshwater invertebrates, which are a food source for salmon and other fish species. Caution is advised to avoid drift and runoff into fish bearing waters.

## **AGRICULTURAL USE REQUIREMENTS**

**MANAGING RESISTANCE:** Repeated use of the same class of miticides or miticides with similar modes of action can lead to the buildup of resistant mite strains. *Zeal* should be used in alternation with other miticides possessing dissimilar modes of action and/or with other chemical classes of miticides. Follow local, state and federal IPM and Resistance Management (RM) recommendations. Read and follow all product labels before applying any miticide.

**RESTRICTIONS/PRECAUTIONS:**

1. Do not apply more than 3 oz *Zeal* per acre per season or make more than one application per season.
2. Do not apply to alfalfa grown for fresh market or processing.
3. Do not apply this product through any type of irrigation system.
4. Do not cut the treated seed crop for hay or forage.
5. Do not graze the treated seed crop.
6. Screenings from processed seed is prohibited from food or feed channels.
7. Seed from the treated crop cannot be used for sprouting for human or animal consumption.
8. All treated seed must be tagged at the processing plant as "Not for human or animal consumption."
9. All requirements in IDAPA 02.03.03.800, Rules Governing Pesticide and Chemigation Use and Application must be followed.

**NO AMENDMENTS**

This pesticide does not have an established pesticide residue tolerance for this crop. Consequently, no portion of this seed crop may be used or distributed for food or feed. All seed screenings and plant parts must be disposed of in such a manner that they cannot be distributed or used for food or feed purposes.

**All restrictions listed in the Idaho Rules Governing Pesticide & Chemigation Use & Application, IDAPA 02.03.03.800, must be followed.**

This label and the EPA-registered label must be in the possession of the user at the time of mixing and pesticide application.
