Fleabane, Hairy ( <i>Conyza bonariensis</i> )	6-12 oz/A*	Apply <i>Chateau</i> Herbicide SW prior to weed emergence.

\*Refer to label for rates based on soil texture and target weed(s). For Asparagus, Caneberry, and Garlic, do not apply more than 6 oz of *Chateau* Herbicide SW per acre per application

1. Always read and follow all label directions when using any pesticide alone or in tank-mix combinations. Follow the most restrictive labeling applies when using a tank-mix.
2. Apply with labeled burndown herbicide for control of emerged weeds.
3. Do not apply when conditions favor off-site movement of spray. Off-site movement (drift) can result in spotting of non-target vegetation.
4. Do not apply within 30 foot of adjacent desirable vegetation.
5. Refer to label for PHI for specific crops.
6. Apply with 20 to 40 PSI.
7. Apply with minimum of 25 GPA.
