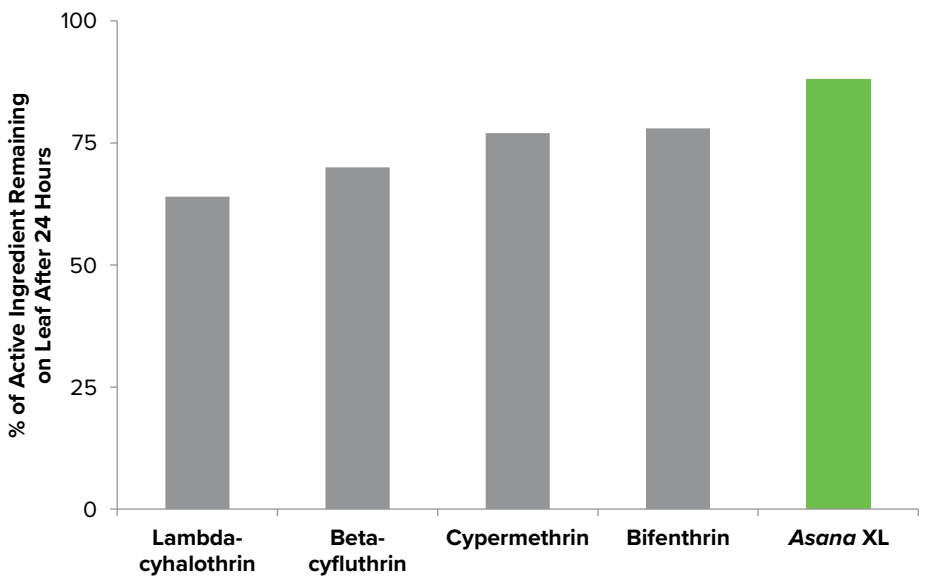

Asana XL—Superior UV Stability

A study comparing *Asana XL* to other synthetic pyrethroids found that *Asana XL* was the most UV stable, which means that more of the active ingredient is available to control target pests.

Study conducted on Lepidopteran larvae (caterpillar) exposing larvae to treated foliage after having plant material exposed to 24 hours of UV light in a growth chamber.

- ▶ Fields can be entered 12 hours after application. No mandatory posting notice required.
